

Investment Structure

The Coffee Impact Fund is professionally managed by independent fund managers who oversee strategic investments in Vanuatu's coffee sector. Investors receive preferential shares in the fund holding company, with no requirement to establish separate corporate structures.

Applicants are issued redeemable share certificates in the fund. At the end of the four year period the fund manager will contact the applicant to arrange redemption of the investment from the fund along with any returns.



Pre-Approval

Upon confirmation of no adverse findings, a pre-approval is granted, allowing the full application process to proceed.

Stanford Knight reviews the documentation and submits the application with 25% of the government fee.

Citizenship Commission Approval

Approval in Principle Letter issued upon application approval by the Citizenship Commission.

Full payment of government citizenship fee and investment in the Vanuatu Coffee Impact Fund is required before issuing citizenship certificates.

Oath of Allegiance & Passport Issuance

Conducted via video conference, followed by the issuance of citizenship certificates and passports.
