

There are no requirements to register a separate company for the investment and the fund issues CIIP investors preferential shares in the fund holding company.

Due Diligence

Submission of required documents and processing fee of \$5,000 through the Financial Intelligence Unit (FIU).

Pre-Approval

Upon confirmation of no adverse findings, a pre-approval is granted, allowing the full application process to proceed.





Application Submission

Stanford Knight reviews the documentation and submits the application with 25% of the government fee.

Citizenship Commission Approval

Approval in Principle Letter issued upon application approval by the Citizenship Commission.





Final Payment

Full payment of government citizenship fee and investment in the Vanuatu Coffee Impact Fund is required before issuing citizenship certificates.

Oath of Allegiance & Passport Issuance

Conducted via video conference, followed by the issuance of citizenship certificates and passports.

Application Submission

Submission of the full application and initial fee payment to the Citizenship Commission.

Approval in Principle

Receipt of an Approval in Principle Letter from the Citizenship Commission.





Final Payment

Submission of the balance of fees prior to the issuance of citizenship certificates.

Oath of Allegiance & Passport Issuance

Oath of Allegiance conducted remotely, followed by delivery of citizenship certificates and passports.

Vanuatu, officially the Republic of Vanuatu, is a South Pacific island nation made from an archipelago of 83 islands with a rich history and culture. Vanuatu is located in the South Pacific Ocean east of Australia, north-east of New Caledonia, and west of Fiji.

History: Formerly the jointly administered Anglo-French condominium of the New Hebrides, Vanuatu achieved independence in 1980. The name Vanuatu means "Our Land Forever". The capital, largest city, and commercial centre is Port-Vila, on Éfaté.

Population: 335,000 (2023 est).

Language: Official languages include English, French, and Bislama.

Travel: There are regular flights to Vanuatu with travellers arriving via Bauerfield International Airport in Port Vila from Australia, New Zealand, New Caledonia, the Solomon Islands and Fiji. New direct flights from China are coming soon. **Economy:** Kava, beef, copra, timber, and cocoa are the most important exports; Australia, New Caledonia, Japan, and New Zealand are the main export destinations. Imports – mainly of machinery and transport equipment, food and live animals, and mineral fuels – come principally from Australia, Singapore, New Zealand, and Fiji. Since Independence, Vanuatu's tourism and offshore financial services have emerged as important earners of foreign income.

Currency: Vanuatu currency is the vatu (VUV) which is pegged to the USD and provides stability. USD and AUD are commonly used throughout Vanuatu.

Banking: The major banks of Australia, New Zealand, and France, such as Bank South Pacific (Vanuatu) Limited, ANZ Bank (Vanuatu) Ltd., and BRED (Vanuatu) Limited, have branches in Vanuatu. Online banking is available.
